Mapping Tools

The Food and Nutrition Service (FNS) mapping tools are designed to assist State agencies, partners and sponsors interested in using data to build summer meal capacity and target new sites. - *Area Eligibility Mapper*
This map shows the locations of areas served by schools where at least 50 percent of enrolled children are eligible for free or reduced-price meals.

Effective site promotion involves a variety of platforms, including social media, websites, and texting. FNS also has print and media resources available to reach families and communities through traditional forms of outreach.

Download and customize flyers, bookmarks, postcards, public service announcements (PSA), and more, in both English and Spanish, to let families know about the availability of Summer Meals and how to find meal locations near them.

Events

Partners and sponsors can host events to promote Summer Meals. Well-advertised, family-friendly events are great ways for sponsors to promote their sites. Events could be as simple as inviting parents for a day of fun, or a major event with public officials, celebrities, and media. Co-hosting an event is a great way to combine city, State, and local nonprofit agency efforts to raise awareness, provide information, and encourage participation.

Share Our Strength No Kid Hungry Texting Campaign

Texting provides convenient, real-time access to local Summer Meal site information. Using the No Kid Hungry free texting service, families may text "FOOD" or "COMIDA" to 877-877 to receive a text back with information about summer meal sites in their neighborhood. The texting service also provides information about how to find other food resources in the area. Share Our Strength, a USDA partner organization that runs the No Kid Hungry initiative, welcomes and encourages Summer Meal sponsors to include information about the texting service in their outreach materials.
