

# Summer Food Service Program (SFSP)

## State Deadlines for Sponsors

Although it is a Federal program, the SFSP is administered at the State level. Federal regulations require that all sponsor applications be submitted to the State agency by **June 15<sup>th</sup>**. States may establish earlier annual deadlines, but are encouraged to work with sponsors wishing to apply after the State's earlier deadline. If a sponsor has already missed the deadline listed below, contact the State agency that administers Summer Meal Programs to discuss extension options.
