State	When will March SNAP Benefits be issued?
Alabama	Alabama will issue March benefits on March 4, 2019. April benefits will be issued April 4-13 for households with scheduled issuance between April 4 -13, and on April 13 for households with scheduled issuance dates between April 14- 23.
Alaska	Alaska will return to the normal March schedule of March 1, 2019.
Arizona	Arizona will stagger issuance of March benefits between March 1-6, 2019.
Arkansas	Arkansas will issue March benefits on March 4, 2019.
California	California will issue March benefits on March 1, 2019.
Colorado	Colorado will stagger issuance of March benefits between March 1-10, 2019.
Connecticut	Connecticut will return to the normal March schedule with staggered issuance between March 1-3, 2019.
Delaware	Delaware will issue March benefits on March 4, 2019, and April benefits on April 13, 2019.
District of Columbia	The District of Columbia will issue March benefits on February 26, 2019.
Florida	Florida will issue half of each household's benefit on March 1, 2019, and the other half on the normal issuance schedule (between March 1 - 28, 2019)
Georgia	Georgia will issue half of each household's benefit on March 2, 2019, and the other half on the normal issuance schedule (between March 5 -23, 2019).
Guam	Guam will issue March benefits on March 1, 2019.
Hawaii	Hawaii will return to the normal March schedule with staggered issuance between March 3-5, 2019.
Idaho	Idaho will return to the normal March schedule with staggered issuance between March 1-10, 2019.
Illinois	Illinois will issue March benefits on March 1, 2019.
Indiana	Indiana will issue half of each household's benefit on February 22, 2019, and the other half will be staggered with households receiving their benefit between March 1-20, 2019.
Iowa	Iowa will return to the normal March schedule with staggered issuance between March 1-10, 2019.
Kansas	Kansas will issue March benefits on March 1, 2019.
Kentucky	Kentucky will issue March benefits on March 1, 2019, and will stagger the April issuance between April 1-10, 2019.
Louisiana	Louisiana will stagger issuance of March benefits between March 1-2, 2019.
Maine	Maine will issue March benefits on March 3, 2019.
Maryland	Maryland will issue March benefits on March 6, 2019.
Massachusetts	Massachusetts will stagger issuance of March benefits between March 1-4, 2019.
Michigan	Michigan will stagger issuance of March benefits between March 3-5, 2019, and will stagger issuance of April benefits between April 3-12, 2019.
Minnesota	Minnesota will stagger issuance of March benefits between March 4-6, 2019.
Mississippi	Mississippi will issue March benefits on March 4, 2019, and will issue April benefits on April 12, 2019.

State	When will March SNAP Benefits be issued?
Missouri	Missouri will return to the normal March schedule with staggered issuance between March 1-22, 2019.
Montana	Montana will issue March benefits on March 2, 2019.
Nebraska	Nebraska will issue March benefits on March 1, 2019.
Nevada	Nevada will return to the normal March schedule of March 1, 2019.
New Hampshire	New Hampshire will return to the normal March schedule of March 5, 2019.
New Jersey	New Jersey will issue March benefits on March 1, 2019.
New Mexico	New Mexico will issue March benefits on the March 1, 2019. April benefits will be issued between April 1 -10, 2019.
New York	For "Upstate" districts, New York will be issuing all benefits on March 1 and 2, 2019. For NYC, the issuance schedule will be compressed into the first seven days of March.
North Carolina	North Carolina will issue March benefits on March 3, 2019. April benefits for household's who receive their benefits April 3-11, 2019 will be on the normal schedule. Household's who normally receive their benefits April 13-21, 2019 will receive their benefits on April 12, 2019.
North Dakota	North Dakota will return to the normal March schedule of March 1, 2019.
Ohio	Ohio will issue half of each household's March benefit on February 22, 2019 and issue the remaining half on the normal issuance schedule between March 2-20, 2019.
Oklahoma	Oklahoma will issue March benefits on March 1, 2019.
Oregon	Oregon will issue March benefits on March 1, 2019.
Pennsylvania	Pennsylvania will return to the normal March schedule (staggered over the first 10 business days of March).
Rhode Island	Rhode Island will return to the normal March schedule of March 1, 2019.
South Carolina	South Carolina will issue March benefits on March 5, 2019.
South Dakota	South Dakota will return to the normal March schedule of March 10, 2019.
Tennessee	Tennessee will return to the normal staggered issuance schedule for those households that receive benefits between March 1- 6, and will issue on March 6, 2019 for those households that normally receive benefits from March 7- 20.
Texas	Texas will stagger issuance of March benefits between March 1-10, 2019.
Utah	Utah will issue March benefits on March 5, 2019.
Vermont	Vermont will return to the normal March schedule of March 1, 2019.
Virgin Islands	The Virgin Islands will return to the normal March schedule of March 1, 2019.
Virginia	Virginia will issue March benefits on March 1, 2019.
Washington	Washington will issue March benefits between March 2-11, 2019.
West Virginia	West Virginia will issue March benefits on March 1, 2019.
